Maltby Lilly Hall Academy Parent Governor Vacancy

I am writing to inform you that Maltby Lilly Hall Academy has a Parent Governor vacancy.

Joining the Local Governance Committee as a Parent Governor offers you the opportunity to make a contribution to the life and work of Maltby Lilly Hall Academy. Governors play a key role in the strategic leadership of the Academy and raising of standards. Being a Governor can be very rewarding and will provide you with the opportunity to work as part of a team and gain new skills. Please note that a very important duty of any Governor is to regularly attend meetings and you should ensure that you are able to do this before applying. It is not essential that you have prior experience as training and support is provided.

The Local Governance Committee meetings are held four times per year and there are usually three Raising Attainment and Curriculum (RAC) meetings per year. Meetings are held at 5.30pm and last for around 2 hours. Governors are also encouraged to make visits to the Academy and may attend school and Trust events as a representative of the Local Governance Committee.

Within the Maltby Learning Trust, we have a shared Governance model which means that Maltby Lilly Hall Academy shares members of the Governing Committee with Maltby Manor Academy. Within each of the 2 hour Local Governance Committee meetings, the business of both schools will be addressed. Parent Governors at Maltby Lilly Hall Academy automatically become Governors at Maltby Manor Academy.

Governors are expected to commit to attending meetings and engage in training offered through Maltby Learning Trust. If you would like to know more about the role of a Governor, further information is available on the website. Please be aware that Parent Governors are elected to view business 'through the eyes of parents' and do not represent other parents of children attending the school.

If you are interested in becoming a Parent Governor, please complete the attached expression of interest form via the link <https://forms.office.com/e/PYpdRHEgAm> by 9.00am on Monday 20th January 2025. If we receive more nominations than vacancies, a ballot of Parents / Carers will need to be held. We would ask therefore, that as part of the form, you write a brief personal statement regarding what you can offer the Local Governance Committee. This will be circulated to all Parents / Carers in the event of a ballot. If you are unable to complete the form via the link, a paper copy is available upon request.

Please note that Maltby Learning Trust is committed to safeguarding and promoting the welfare of children and young people therefore all Governors are required to undergo a DBS check before being appointed.
